Please read the following guidelines before completing and submitting this registration form.

- Exhibitor Entitlements & Fees Exhibitor fees entitles each exhibitor to one (1) virtual booth and one (1) Zoom session. Registration is now open, and the fee is \$150; this fee includes conference passes for up to two representatives. *To register, visit https://ctt.mtu. edu/winterops-virtual-exhibit-info* to claim a virtual exhibit. *Only 18 virtual exhibits are available*.
- Virtual Booths Each exhibitor will be assigned one 2. (1) virtual booth. This is a web page that features an introduction to your company and/or highlights your product(s) or service(s). The web page also features a list of the attending representatives and a link to the company website (if desired). The web page can also include a PDF about your company, product(s), and service(s), and an embeddable video (YouTube or Vimeo). All virtual booths will be accessed from the virtual booth portal, which will display logos of all exhibitors in alphabetical order. Virtual booths will be live at 9:00 a.m. on Tuesday, October 13 to coincide with the start time of the conference; they will be live until 4:00 p.m. on Friday, October 16, allowing participants to continue viewing virtual exhibits after the conclusion of the conference sessions.
- 3. Booth Materials Exhibitors must supply virtual booth materials—logo, introductory narrative, list of representatives that will be attending the Zoom exhibitor session, link to company website (optional), PDF (optional), and/or YouTube video link (optional)— to the Center for Technology & Training. Submission of the narrative, the list of representatives, and the company website, and the YouTube link occurs during registration. Submission of the logo and PDF is

done at https://uploads.cttportal.com/ in this manner: logo and PDF must be named using the name of the exhibiting company and both files must be uploaded with *Customer Name* clearly identify as the submitter *and* the exhibiting organization and *Recipient Name* must be *Winter Ops*. Deadline for all submissions is *September 30, 2020*.

- 4. Zoom Session The virtual exhibit includes an exclusive 30-minute Zoom session.
